Closing Bell:

BSE Sensex closed higher by 287 points, or 0.97%, to 29,943, while the Nifty 50 rose 89 points, or 0.96%, to 9,307.

Market benchmark Nifty surged past the 9,300-level for the first time on Tuesday, fuelled by a rally in Reliance Industries Ltd (RIL) and other bluechip shares on upbeat earnings. Positive Asian cues and a higher opening in European markets also added to the momentum. The 50share NSE Nifty soared 82.45 points, or 0.89%, to quote at its new lifetime high of 9,300.40. It broke the previous record of 9,273.90 reached on 5 April.

The rupee appreciating to 64.21 against the dollar (intra-day) at the forex market too boosted sentiments. RIL shares surged 1.21% to Rs 1,433.50 after the company yesterday reported a record fourth quarter net profit of Rs 8,046 crore.

Globally, Japan's Nikkei surged 1.90%, Hong Kong's Hang Seng rose 1.31%, while Shanghai Composite Index gained 0.16%. In Europe, London's FTSE rose 0.22%, Paris CAC 40 gained 0.18% and Frankfurt's DAX inched up 0.03% in early deals.

Bharat Heavy Electricals Ltd shares rise 3% to Rs181.15 after the company said it won orders worth Rs10,000 crore for 1,320 MW Super Thermal Power Project in Bangladesh.

Wipro Ltd shares rise 1.3% to Rs498.40 ahead of its March quarter earnings. the company may post net profit of Rs2,122.60 crore, and clock in net sales of Rs13,817.60 crore.

IDFC Bank Ltd shares rise 1.1% to Rs59.50 ahead of its March quarter earnings. the company may post a net profit of Rs132.10 crore.

Biocon Ltd rose 5% to Rs1,119 after the company said its board will meet on 27 April to consider a bonus issue.

Today is the last day of trading in Cairn India. The stock will be suspended from trading in equity and equity derivatives segment from Wednesday, as the cash-rich oil producer is set to get merged with its debt-ridden parent Vedanta. As per schedule, Cairn India shareholders, who will become shareholders of Vedanta as on record date, would also receive an interim dividend of Rs 17.70 per equity share in addition of Vedanta shares.

Shares of Strides Shasun climbed nearly 3 per cent in Tuesday trade after the drugmaker said its Cuddalore facility in Tamil Nadu has successfully completed inspection by the US health regulator. In a filing to BSE, the company said that it's active pharmaceutical ingredient (API) manufacturing site at Cuddalore was recently inspected by the United States Food and Drug Administration (USFDA)", Strides Shasun said in a filing to the BSE.

Power producer Tata Power Co. Ltd plans to sell non-core investments and improve efficiencies to counter the impact of the Supreme Court ruling that disallowed it to charge higher tariff from its Mundra plant.

- The rich valuations of Avenue Supermarts Ltd, the owner of D-Mart, are finally beginning to worry analysts. A month after Avenue Supermarts's blockbuster debut on the bourses, Kotak Institutional Equities has come out with the first sell rating for the grocery retail chain. - UltraTech Cement Ltd on Monday said its consolidated net profit for the March quarter fell 11.3% from a year ago due to higher total cost and tax expenses.






